

# CYCCM Boat Lease Agreement

## I. Introduction:

The CYCCM leases Laser Radials, 420's and other owned boats for either or both of the Sailing Sessions at CYCCM or for individual racing events hosted by CYCCM in Cape May.

### A. Sailing Sessions:

1. Sailing Session I is scheduled as shown on the calendar for the sailing year.
2. Sailing Session II is scheduled as shown on the calendar for the sailing year.
3. The boats are only available for rental for the intermediate/advanced sailing sessions, which are:
  - Monday afternoon sailing class
  - Tuesday afternoon sailing class
  - Wednesday afternoon sailing class
  - Thursday morning races

VI. Conditions/Limitations on Use of Boat:

A. Boat can only be used:

1. During Sailing Session, or
2. In the case of an individual racing event, only in conjunction with that event.

B. Boat cannot otherwise be used at any other time.

C. Boat can only be used in the area proscribed for Sailing Sessions or for racing events hosted by CYCCM.

D. Only sailors qualified for intermediate/advanced sailing sessions may rent boats and must be a CYCCM Member.

E. Renter shall never leave boat unattended.

F. Renter and crew must wear lifejackets at all times.

VII. Liability for Damage/Assumption of Risk/Release/Indemnification/Hold Harmless

A. Renter is responsible for and agrees to pay for any and all damage or loss of parts beyond normal wear. Normal wear is considered to be minor scratches and scrapes that result during normal usage. Normal wear does not include: (1) ripped sail (2) bent or broken spars, (3) holes or cracks in the hulls, (4) lost dagger board or lifejackets, (5) broken, cracked or lost tillers or tiller extensions, rudders, or tiller connecting bars.

B. Renter uses boat at his/her own risk and is fully responsible for all others who use this boat while rented.

C. Renter releases CYCCM Sailing Foundation from any cause of action, claim, demand or right, in contract, tort, or otherwise which the renter or his/her crew or anyone else who uses boat while rented may have based upon, arising from or due

directly or indirectly to injury to the person, including loss of life, or loss or damage to the property regardless of where such injury/loss/damage occurs.

D. Renter agrees to indemnify and hold harmless CYCCM Sailing Foundation against any liability, loss, damage or expense which may be incurred by CYCCM Sailing Foundation by reason of the assertion of any cause, claim, demand or right against CYCCM Sailing Foundation by any person of the nature referred and described above.

#### VIII. Payment Terms

Renter agrees to pay in full upon submission of rental agreement. *Notice of cancellation must be received at least two weeks in advance of the lease in order to receive a refund. This notice must be confirmed by sending an email to info@cyccm.com*
